# 2. Minutes of the 13<sup>th</sup> General Assembly

The minutes are unanimously approved.

#### 3. Report of the president

GR gives first a quick look back at the 2007 SSB Annual Meeting in Neuchâtel. The event gathered 80 participants under the theme of micro- and nanotechnologies in medical applications. GR thanks again PX Group for the organization of the meeting and their generous financial contribution. During the 2007 General Assembly, some

changes occurred in the Executive Committee. After Jacques Lemaître stepped down from the presidency, G. Richards was elected president, M. Bohner vice-president, P.-H. Vallotton secretary and T. Brunner web editor and student rep. Heinz Lüthy, who stepped down from the EC, was awarded a life long honorary membership for his role in the foundation of the SBB and in the EC.

In 2007 the SSB awarded several student prizes for best oral or poster presentations, both at the SSB Annual Meeting (CHF 1000) and at Biosurf (CHF 1000). The SSB sponsored also the participation of Romanian scientists to the SSB 2007 (CHF 1000). GR reminds the audience that the SSB EC had approved the expenditure for six awards of 500 CHF each year to help student members attend a scientific meeting related to biomaterials, and that the awardees can use the money for travel / accommodation help. In 2007, only 1 student travel award (CHF 500) was distributed, due to the lack of applicants.

During the last year the EC decided to implement new initiatives in order to attract more attendants to the Annual Meeting: organization of a networking "farewell" apéro at the end of the sessions, invitation letter from the SSB president to all heads of research institutes in Switzerland. GR insists on the role of SSB (and in particular of its Annual Meeting) in promoting translational research in biomaterials in Switzerland.

ESB2009: the organization of the 2009 Congress of the European Society for Biomaterials in Switzerland has progressed quite a lot due especially to the efforts of a 3 EC members, namely C. Wandrey, M. Bohner, and G. Richards. GR asks the audience to have a look at the ESB2009 website (www.esb2009.org) for more details.

Finally GR mentions the *European Cells & Materials Journal*, the official journal of the SSB, which offers simplified procedures for publication (<u>www.ecmjournal.org</u>).

# 4. Report of the treasurer

A. Salito presents the accounting for 2007. The negative result of CHF 4'506.60 was mainly due to early payments for ESB 2009, whereas income remained in accordance with the budget. On December 31, 2007, the fortune of SSB amounted CHF 30'317.25.

# 5. Report of the auditors

Beat Gasser reports in the names of A. Gisep and himself. Accounting 2007 of the SSB was verified by the 2 auditors and found well kept. All the numbers presented were correct. Therefore B. Gasser proposes to accept accounting for 2007.

The proposal is unanimously accepted.

# 6. Budget 2008

The 2008 budget should bring a negative result of CHF 8375 due to further payments related to the preparation of ESB 2009. Other expenses for 2008 include the organization of SSB2008 in Basel and student awards, whereas main revenues will be collected from SSB2008 attendance fees, membership fees, and sponsors.

The budget 2008 is unanimously accepted.
