1. Approval of the Agenda

2. Protocol of the 5th General Assembly, Zürich, October 8, 1999

3. Report by the treasurer

During the year 1999 the society had a net income of CHF 4'299.95, compared to total expenses of CHF 1'833.80. By June 6, 2000, the fortune of the SSB was CHF 17278.45.

4. Report by the Auditor

A. Gisep and K. Ruffieux revised the accounts and suggested to discharge the treasurer. Approval with unanimity

5. Buget 2001

The EC has to prepare a Budget for 2001 with a well balanced account. Wherein are included CHF 1000.- for a poster price (to the group of authors) and CHF 500.- for oral presentation (to the speaker).

6. Membership Fees for 2000

Proposed by the EC: CHF 50.- for individual members, CHF 10.- for students and CHF 300.- for institutional members. Approval with unanimity

7. Report by the President

- The Executive Committee (EC) met twice: December 8, 1999 and April 10, 2000
- SSB Web Page was established
- E. Wintermantel will take over the "Zentralinstitut für Medizintechnik" of the Technical University of Munich and therefore leave Switzerland and the EC of the SSB.

8. Co-operation with SVMT

After discussion a mandate was given to the EC to clarify the situation with the SVMT especially with respect of a possible adherence of the SSB to the European Society of Biomaterials (ESB).

9. Web Page
